1 Overview

You have now received the **2021-Q1 geocoding dataset**. Each year millions of new addresses and corrections are made to the geocoding data. Using the most up-to date address data will help you to achieve a higher match rate and more-accurate matches.

1.1 Who should install?

All clients that use *CRA Wiz* and *Fair Lending Wiz* as their geocoding provider should install this update.

1.2 Where to install

The update should be installed only on the server. To find the current location of your geocoding data go to **System Maintenance > Data and Application Mapping** and check the path next to **Geocoding Data – 2010**. If you do not have access to the application, below is a SQL Query that can be run to determine the current location of the data:

```
use objectstore
select Location from dbo.elementlocations
where ElementName='Geocoding Data - 2010'
```

1.3 Prerequisites

CRA Wiz and *Fair Lending Wiz* 7.5 recommended.

1.4 Required permissions

The geocoding installer uses an executable to write files to a drive of your choice. A Windows administrator account is recommended.

1.5 Required disk free space

Full US: 11GB
Central: 4.5GB
Midwest: 4.0GB
Northeast: 4.5GB
Southwest: 4.5GB
Southeast: 5.0GB
Western: 5.0GB

1.6 Approximate install time

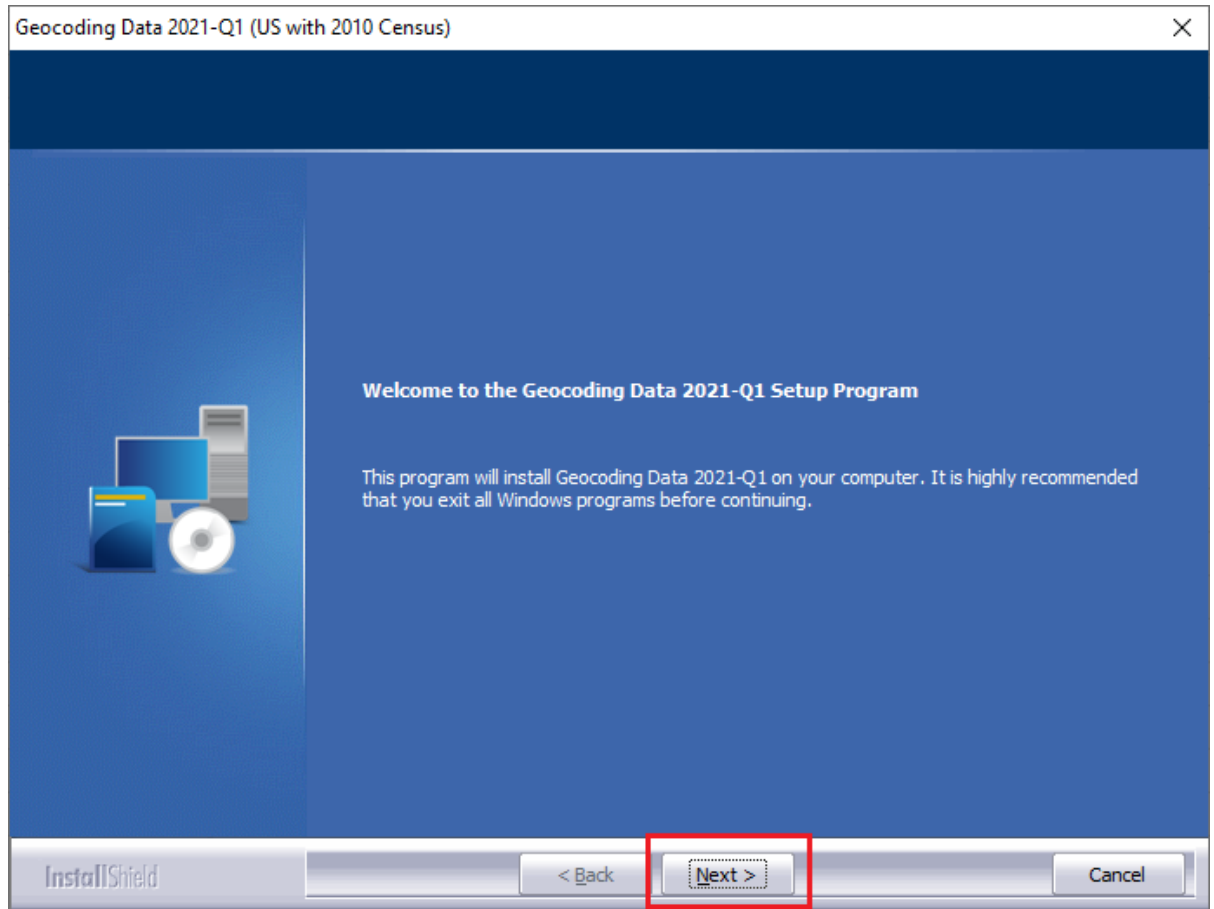
Full US: approximately 15 minutes.
Regions: 2.5 minutes per region.

2 Installation Instructions

To install geocoding data, do the following:

1. Using the **2021-Q1 Geocoding Data Install**, run the **Setup.exe**.

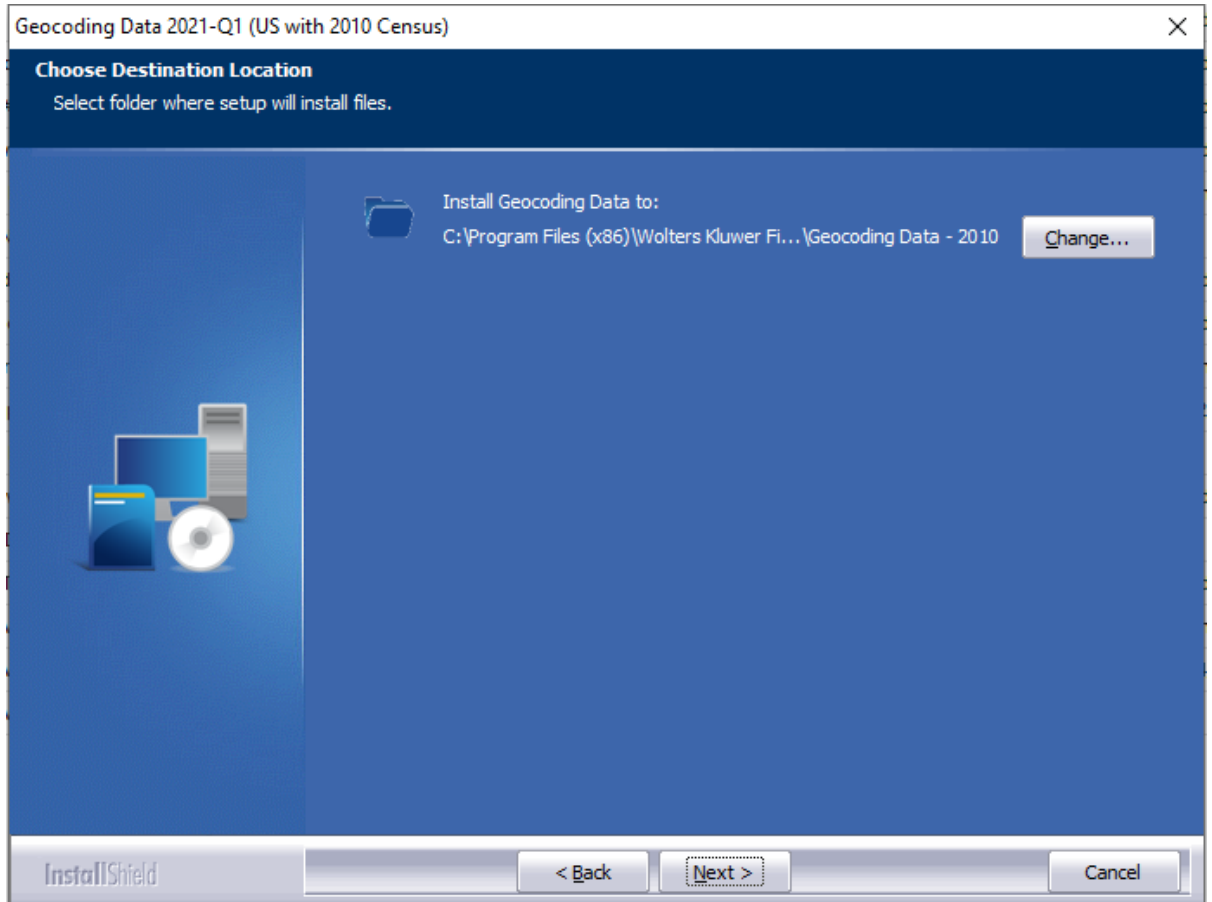
The installer displays the **Welcome** screen:



2. Click the **Next** button.

The installer displays the **Choose Destination Location** screen.

3. In the **Choose Destination Location** screen, do one of the following:



- If you want to accept the default installation location:

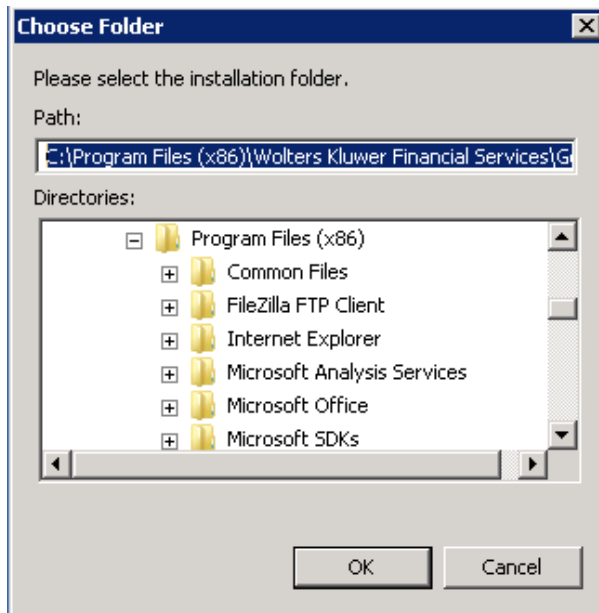
C:\Program Files (x86)\Wolters Kluwer Financial Services\Geocoding Data – 2010

...click the **Next** button. The installer displays the **Ready to the Install Program** screen. For procedures, go to **Page 7**.

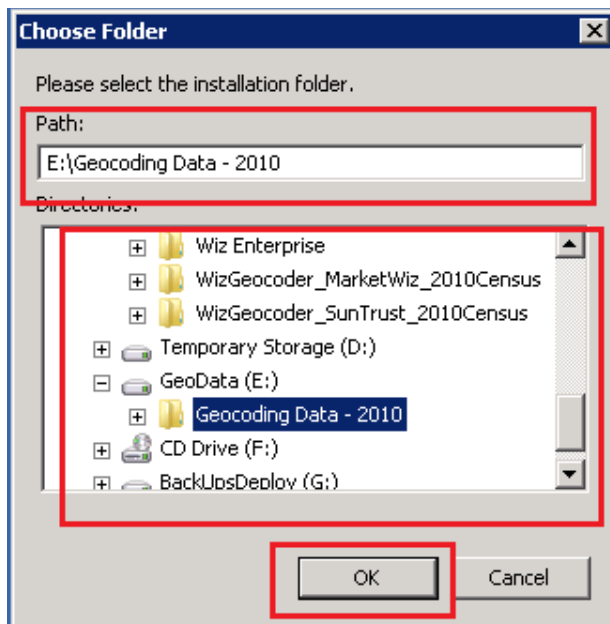
- If you want to select a location to install the data, follow these steps:
 - 3.1. Click the **Change...** button:



The installer displays the **Choose Folder** dialog box:



3.2. Use the dialog box controls to select an installation location:



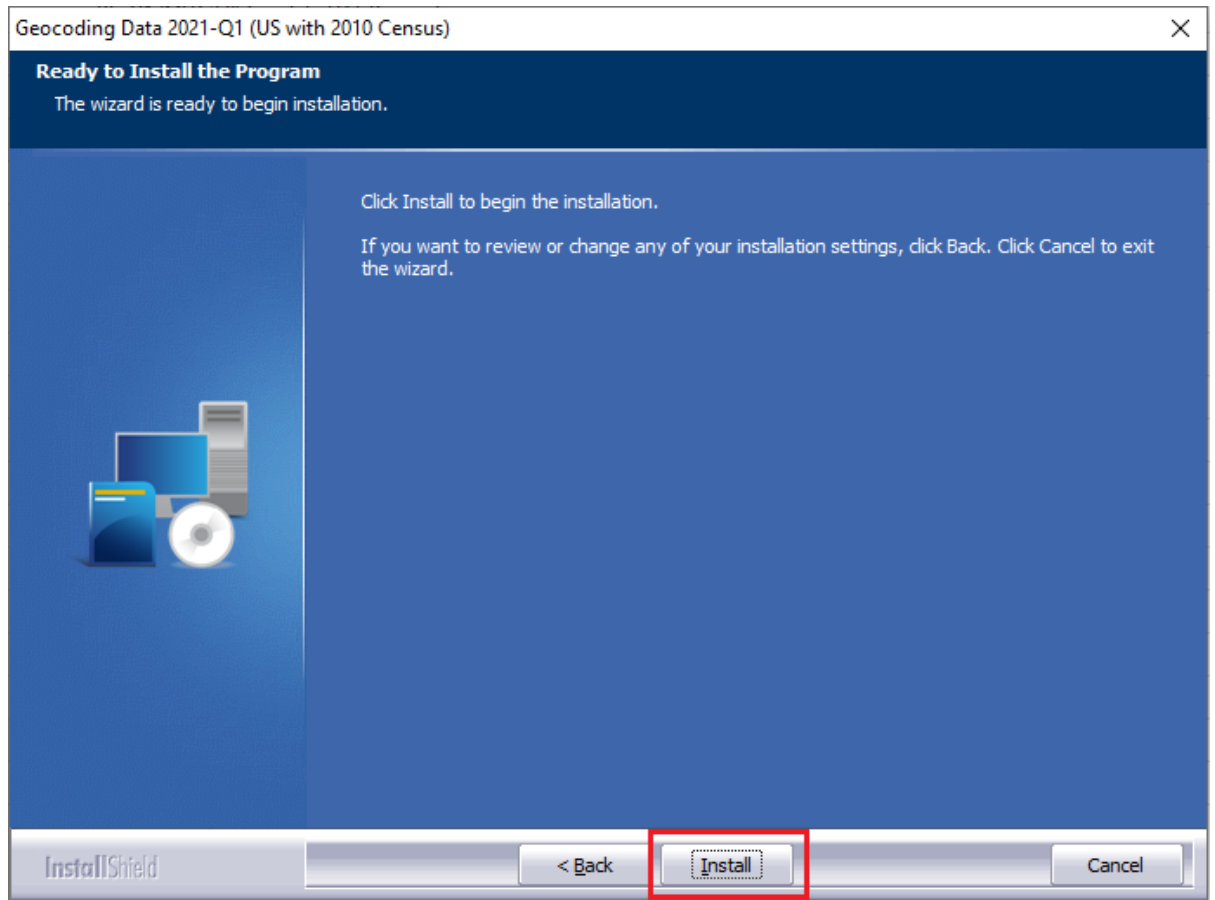
3.3. Click the **OK** button.

The installer closes the Choose Folder dialog box.

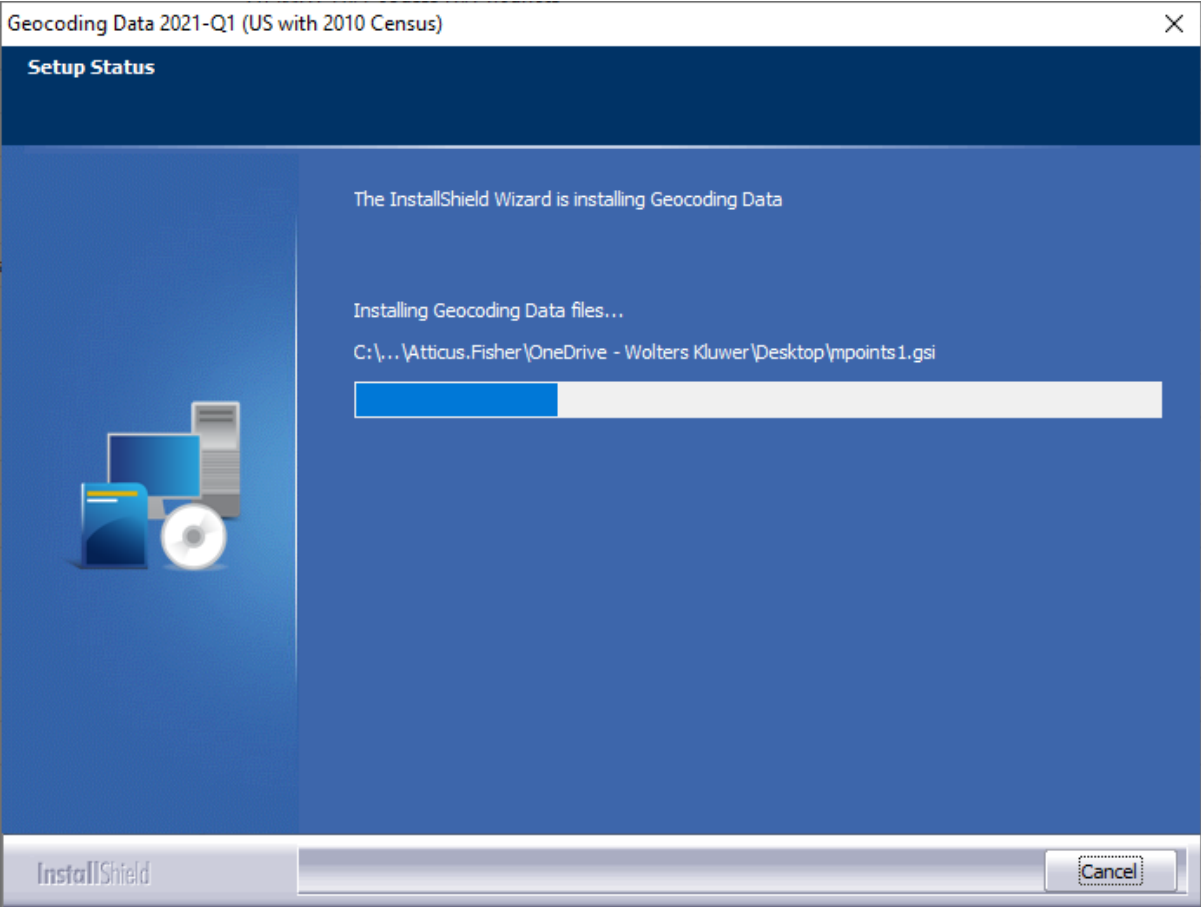
3.4. In the Choose Destination Location screen, click the **Next** button.

The installer displays the **Ready to Install the Program** screen.

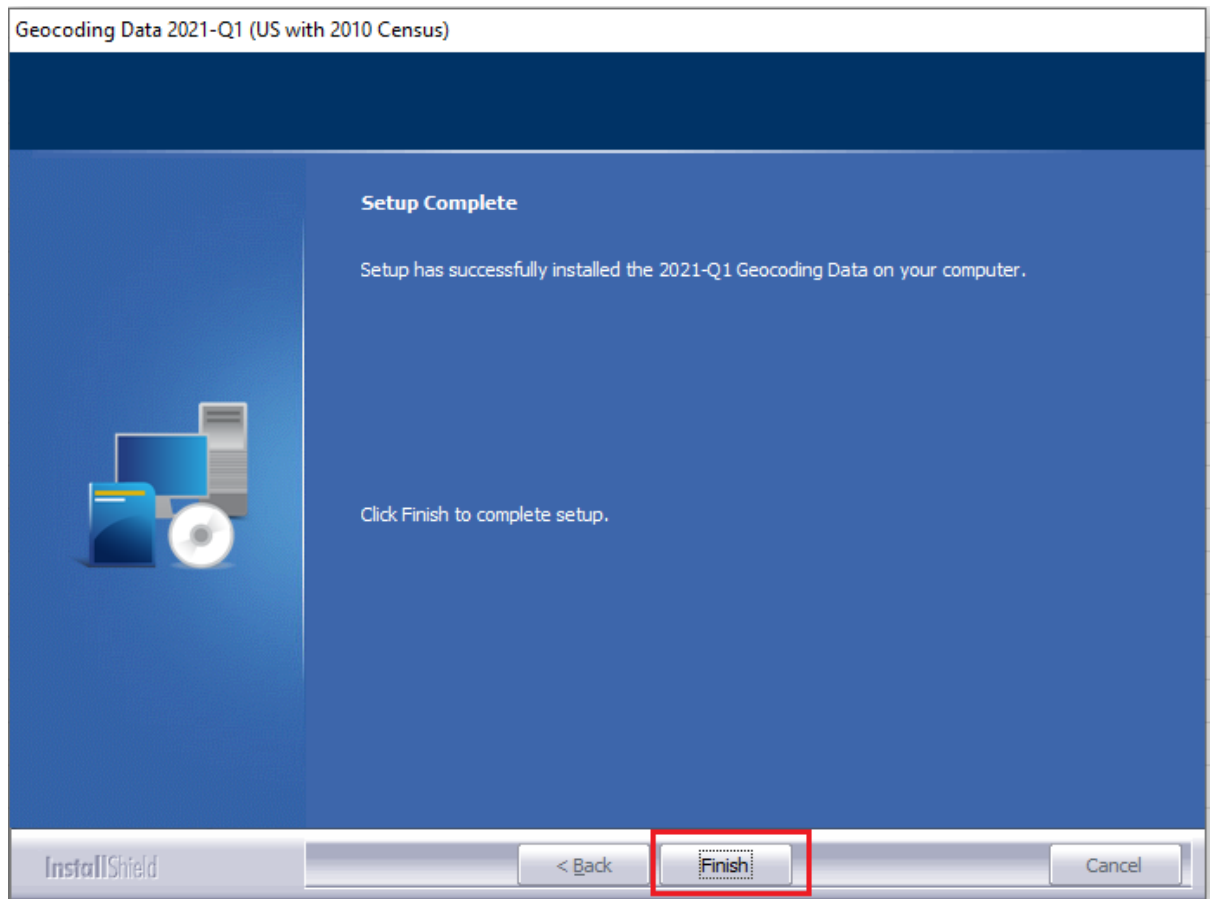
4. In the **Ready to Install the Program** screen, click the **Install** button to start the installation:



The installer displays the **Setup Status** screen:



When installation is complete, the installer displays the **Finish** screen:



5. Click the **Finish** button to exit.

3 Note about Geocoding Data Path

If you have installed Geocoding Data in a client/server environment **for the first time**, you need to update the geocoding data path to a **shared folder** (i.e., instead of the drive letter that the installer uses). This path can be updated using the **Data and Application Mapping** section of the CRA Wiz and Fair Lending *Wiz System Maintenance* screen (as seen below).


4 Confirming Installation

In **CRA Wiz** and **Fair Lending Wiz**, do the following:

1. Go to **Main > System Maintenance**.
2. Note the path listed next to the **Geocoding Data 2010** entry.

In **Windows**, do the following:

1. Launch **Windows Explorer**.
2. Use Windows Explorer to navigate to the path you noted in **Step 2** above.
3. Open the **geo32ver.txt** file in a text editor (such as **Notepad**). You should see the version below:



```
geo32ver.txt - Notepad
File Edit Format View Help
[DATA]
Version=2021-Q1
Census=2010
Geography=US and Territories
```

If you do not see this version information, either the install did not complete successfully or the path in System Maintenance is incorrect.

5 Testing Addresses

The addresses below can be used to test that your geocoding data has been updated. Each address will receive an exact parcel match with the latest geocoding data:
