Overview - Metropolitan Statistical Areas

On 9/14/2018 the <u>U.S. Office of Management and Budget ("OMB"</u>) released the revised delineations of Metropolitan Statistical Areas (MSA)/Metropolitan Divisions (MD). The Federal Financial Institutions Examination Council (FFIEC) stated that the new MSA/MD definitions will apply to HMDA data analysis and CRA Data collected on or after **January 1, 2019**. These new MSA/MD definitions will change how our customers view their lending data within *Wiz* Solutions and will play an important role in their analysis and lending activity.

The OMB designated four new MSAs and removed two (2) to bring the total count of MSAs/MDs to 412. In addition, there are 31 MDs that must be used instead of MSA codes when reporting within 11 specific MSA geographies. For the purpose of CRA reporting and analysis, these revisions are effective January 1, 2019 and will be validated for CRA data submissions due March 1, 2020.

Explanation of Geographic categories used by OMB (Office of Management & Budget)

The construction of CRA Assessment Areas and the computation of income class for mortgage borrowers requires an understanding of MSAs and other geographic area terminology as defined by the OMB. Geographic components used for CRA and Fair Lending purposes are outlined below

Terminology

- Metropolitan Statistical Area (MSA): Metropolitan Statistical Areas are geographic entities defined by the <u>OMB</u> and used by the Federal Government in collecting, calculating, and publishing Federal statistics. A Metro Area contains a core urban area of 50,000 or more population and includes one or more counties containing the core urban area. MSAs are used for CRA and HMDA purposes except when they contain MDs.
- 2. **Metropolitan Division (MD)**: the term "Metropolitan Division" is used to refer to a county or group of counties within a Metropolitan Statistical Area that has a population core of at least 2.5 million. A Metropolitan Division is a subdivision of a larger Metropolitan Statistical Area. Metropolitan Divisions retain their separate statistical identities since they can function as a distinct social and economic core within the larger region. MDs have their own ID which takes precedence over the MSA ID for CRA and HMDA reporting purposes.

NOTE: MSAs contain full counties, which are not part of the 2019 MSA changes.

Summary of Changes

The new 2019 MSA delineations contains changes to the following:

- 1. MSA numbers
- 2. MSA names
- 3. Shifting of Counties from one MSA/Non-MSA to a new MSA/Non-MSA
- 4. Removed MSAs
- 5. New MSAs

These County shifts will force updates to demographic data. Census tract Median Family Income values are calculated based on the income of the MSA (along with many other variables), therefore, with changes to the Median Family Income of MSAs, census tracts that are contained in that MSA will be impacted. Implications to consider:

- Tract income changes could have an impact on branch placement, goal setting, and investment selection.
- New MSA definitions may reduce the geographic area assigned to non-MSA areas. This could result in more institutions having responsibility under HMDA and CRA.
- Institutions will need to revisit and redraw their assessment areas.
- Institutions undergoing exams that span 2016, 2017, 2018 and 2019 data may have to tell their performance context story for different assessment areas for different years, different census data, as well as different tract income levels from one year to another.

MSA Median Family Income Values and Census Tract Income Levels

The designation of the 2019 MSA/MD boundaries will require the definition of revised MSA/MD Median Family Income values for both new and revised geographies. The FFIEC provided the revised MSA Median Family Income values for the 2019 MSA/MD boundaries on August 5th.

The census tract income level is defined as the census tract median family income as a percentage of the MSA/MD/non-metro area median family income. Therefore, the potential for change in designation in 2019 could be significant.

In summary, the Low and Moderate Income (LMI) landscape of most institutions' assessment area(s) may change with these new 2019 definitions.



Tract Changes due to the updated MSA median family income of the changed MSAs

- Of the 74,135 census tracts, 1,190 changed income categories.
- 297 census tracts went from a Moderate to a Middle or Upper-Income designation.
- 168 census tracts went from Middle or Upper-Income category to a Low or Moderate-income category.
- 72,945 census tracts kept their previous tract category.

Suggested Actions to Manage the 2019 MSA/MD Definitions

- 2019 LMI penetration goals should be revisited in light of the MSA/MD definitions and revised Median Family Income values.
- Any institutions with assessment areas in any of the new or modified geographies will need to revisit and potentially revise their assessment area definitions for 2019.
- Some institutions previously lending exclusively in non-metropolitan areas may find that they now have additional obligations under HMDA and/or CRA.
- Review your redlining analysis, especially for non-metropolitan areas.
- After installation of the new MSA/MD Median Family Income values, update Calculated Fields on all 2019 files to implement these changes.
- Update assessment area maps based on revised MSA/MD boundaries.
- Update public file information.

Timeline

- September 2018: OMB released new MSA delineations.
- April 2019: FFIEC posted the MSA announcement to their website.
- August 2019: FFIEC posted the Median family Income information for the new MSAs.
- ~2 Weeks after FFIEC Release: Wolters Kluwer will post an CRA *Wiz* and Fair Lending *Wiz* update on the *Wiz* Webcenter which will update the geographies in the software with the new MSA income categories.
- January 2020: Customers will need to use these new MSAs for their reporting year of 2019 and update Calculated fields on their 2019 files.

2019 MSA and MD Facts, Figures and Alphabet Soup

- All MSAs and MDs are comprised of whole counties. The 2019 changes do not split counties into multiple metropolitan geographies.
- Non-MSA areas continue to exist in many states, but will consist of much smaller areas, and a few states do not contain non-MSA areas--Delaware, New Jersey and Rhode Island are fully comprised of defined MSA/MD geographies.
- Of the 412 MSAs in the United States and Puerto Rico, 80 are have been updated by the OMB for 2019. For a complete listing of these 80 MSAs, please reference **Table 4** located at the end of this document.



- Eleven (11) MSAs those that contain a single core with a population of 2.5 million or more are divided into subset areas identified as Metropolitan Divisions or MDs. These 11 MSAs represent 31 MDs. For a complete listing of the 31 MDs please reference **Table 5**.
- In summary, there are a total of 381 MSAs and 31 MDs for 2019 HMDA/CRA reporting. The 31 MDs cover the area of the 11 MSAs removed from the geography listing.
