Overview

The CRA Wiz and Fair Lending Wiz 2018 Final Submission Update is specific to HMDA DF file type Submission support. It can be installed only as an upgrade to Version 7.3 Service Pack 2 (Build 73.20.30) or the SB2155 update (Build 73.21.17).

Note: All the changes that were released as part of the SB2155 Update are included as part of this release. As a result, the SB2155 install package has been removed from the *Wiz* Webcenter.

This document provides detailed information for **upgrading** your environment to the latest version of CRA *Wiz* and Fair Lending *Wiz* as well as the **Release Notes** that explain the bug fixes included as part of this release.

Installation Note

During the CRA *Wiz* and Fair Lending *Wiz* program install, the installer checks for a **minimum supported SQL version**. The minimum supported SQL Version for CRA *Wiz* and Fair Lending *Wiz* 7.3 Service Pack 2 is **SQL Server 2008 R2**.

If you attempt to install the software using an earlier SQL version, the installer displays the following error message:

'Error 27504. SQL version requirements not met: DVWCRADB11. This installation requires SQL Server 10.50.6000.34 or later.'

You can click the OK button to acknowledge the message and proceed with installation, however, Wolters Kluwer does not recommend proceeding with the installation if you are not running SQL Server 2008 R2 or higher.

Exporting HMDA DF File to Excel Error

Impact Area: File Management > Export

Fixed the below error when attempting to export a HMDA DF file to Excel after the SB2155 update was applied:

Geocoding: NA Result when Action Taken = 7 or 8

Impact Area: Geocoding

Fixed issue in which geocoding fields (MSA, State, Country, CensusTrac, County_5, Tract_11) were being calculated as NA when Action Taken was 7 or 8.

Note: This update will not change any of the **NA** values that the system set previously for records that have an Action Taken of 7 or 8. Because of this, you should filter your file to isolate these records and then geocode them.

Q617 Edit

Impact Area: Edit checks

Updated the Q617 Edit logic to match the CFPB's implementation.

Note: After you have applied this update, right-click on your 2018 Mortgage DF file(s) in File Management and choose Run Edit Checks > All Edit Checks to refresh your file(s) with the latest Edit Check logic.

V623 Edit

Impact Area: Submission

Updated Submission File output to always use uppercase state abbreviations (example: MA) even if inputted values are lowercase (example: ma) to prevent V623 edits being returned on the CFPB's submission portal.

Q620 Edit

Impact Area: Edit checks Q620 is no longer flagged if the NMLSRID is populated with NA. Note: This issue is applicable only to clients who are partially exempt.

Installation

Important!

Please read the included **Release Notes** before installing this update. The notes contain important information about the enhancements included in this update.

Important!

If you are running CRA *Wiz* and Fair Lending *Wiz* in a networked environment (computers with *Wiz* Client connected to *Wiz* Server), you must install the update on both your *Wiz* Client and *Wiz* Server.

Who Should Install

All clients using CRA *Wiz* and Fair Lending *Wiz* who are utilizing the software for Submission purposes should update.

Where to Install

This update should be applied to both the application and the SQL server. In a typical networked environment, the installation should be run on both a client machine and a server.

Prerequisites

To apply this update to CRA *Wiz* and Fair Lending *Wiz*, you must have Version 7.3 Service Pack 2 (Build 73.20.30) or higher (Build 73.21.17) installed.

Required Permissions

This installation requires writing and modification, SQL server access, and registry modifications. Wolters Kluwer recommends that the user running the install have both Windows admin and SQL Server admin login credentials.

Required Free Disk Space

Client side - 2 gigabytes (GB) Server side - 18 gigabytes (GB)

Approximate Install Time

Client side - 5 minutes Server side - 25 minutes To install the CRA Wiz and Fair Lending Wiz update, follow these steps:

1. Back up your SQL databases.

Wolters Kluwer recommends that institutions back up the below SQL databases prior to installing a CRA *Wiz* & Fair Lending *Wiz* program update:

- ObjectStore
- General
- Procedures

Important!

It is strongly recommended that you exit all Windows[™] programs before running this installation. This installation updates selected program files, but does not overwrite any user imported files or custom settings created in prior versions.

- 2. Download the update to the location where CRA *Wiz* and Fair Lending *Wiz* is currently installed.
- 3. Right-click the setup.exe file.

The software displays a contextual menu.

4. Select Run as Administrator.

The Welcome screen text indicates that you are about to update the current version of CRA *Wiz* and Fair Lending Wiz. If the installer does not detect your current installation of CRA *Wiz* and Fair Lending *Wiz*, please contact **Wolters Kluwer Technical Support at 1-800-261-3111**. When prompted, select **option 1**.

5. Click the Next button.

The software displays the SQL Server Login screen only if the computer on which you are installing the update is running SQL Server. If the installer does not detect SQL Server on your computer, the installer displays the Ready to Install the Program screen. Skip to Step 8.
