1 Overview

The **CRA *Wiz* and Fair Lending *Wiz* 7.4 Service Pack 1 (SP1) Hotfix** release contains updates that resolve the new Fair Lending Regression Module user interface crashing issue, along with updates to Regression Module results output and reporting.

1.1 Who Should Install

All CRA *Wiz* and Fair Lending *Wiz* clients who are licensed for Fair Lending *Wiz* are required to complete this update.

1.2 Where to Install

This update should be applied to the application. In a typical networked environment, the installation should be run on the client machine(s).

1.3 Prerequisites

To apply an update to CRA *Wiz* and Fair Lending *Wiz*, you must have at least the latest major service pack(s) already installed. For example, to upgrade to the Version 7.4 Service Pack 1 (SP1) Hotfix, you must already have Version 7.4SP1 (Build 74.10.44) installed.

1.4 Required Permissions

This installation requires writing and modification, and registry modifications. Wolters Kluwer recommends that the user running the install have both Windows admin login credentials.

1.5 Required Free Disk Space

Client – 400 MB (megabytes)

Workstation – 17.5 GB (gigabytes)

1.6 Approximate Install Time

Client – 4 minutes

Workstation – 10 minutes

1.7 Confirming Installation


Client-side confirmation:

1. Browse to the following location on the computer where CRA *Wiz* and Fair Lending *Wiz* **Client** is installed:

C:\Program Files (x86)\Wolters Kluwer Financial Services\CRA *Wiz* and Fair Lending *Wiz*\FairLendingNG\

2. Locate the **WKFS.CRAWiz.FairLending.exe** file.

3. Confirm the **Date Modified** is **5/21/2020** (see below):

2 Installation

To install the CRA *Wiz* and Fair Lending *Wiz* update, follow these steps:

1. Download the update locally where CRA *Wiz* and Fair Lending *Wiz* is installed.
2. Right-click the **CRAWiz74SP1Hotfix.exe** file.

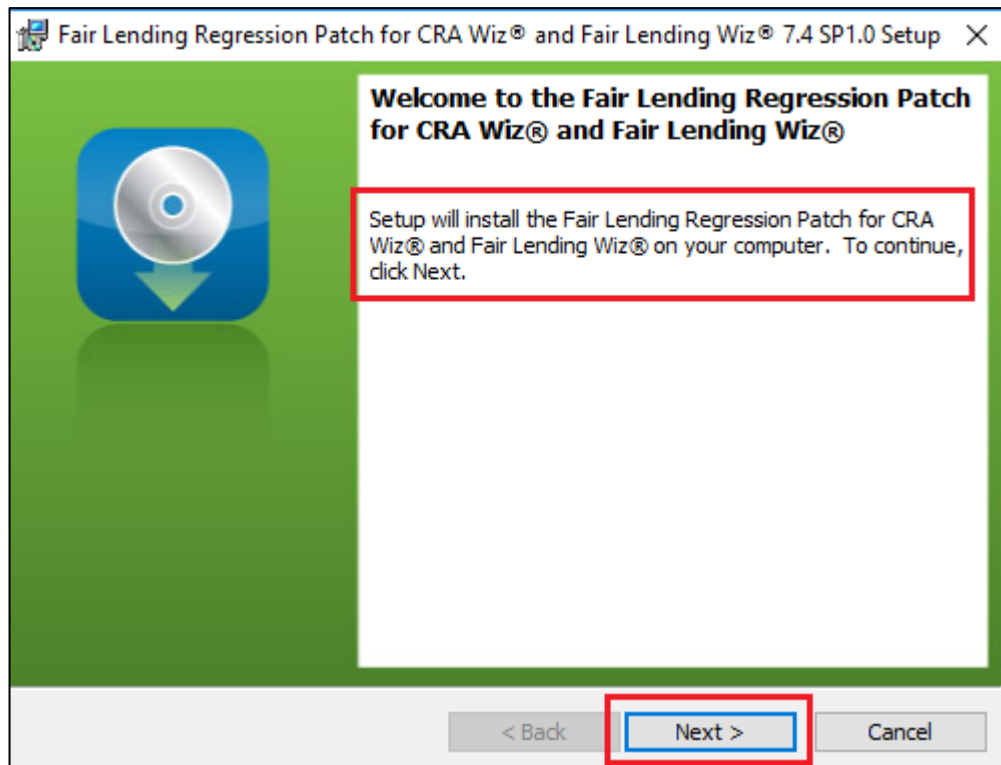
The software displays a contextual menu.

3. Select **Run as Administrator**.

The installer displays the **Welcome** screen.

4. Follow the directions for each of the following screens.
5. Click the **OK** button.

The software displays the **Welcome** screen:

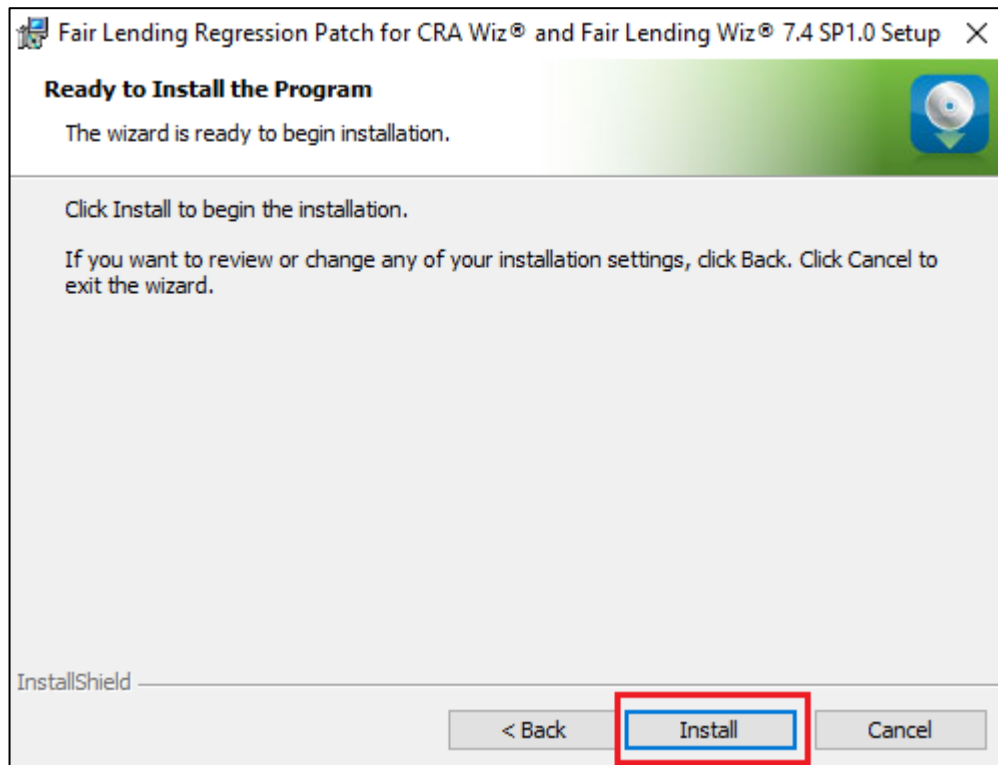


Note:

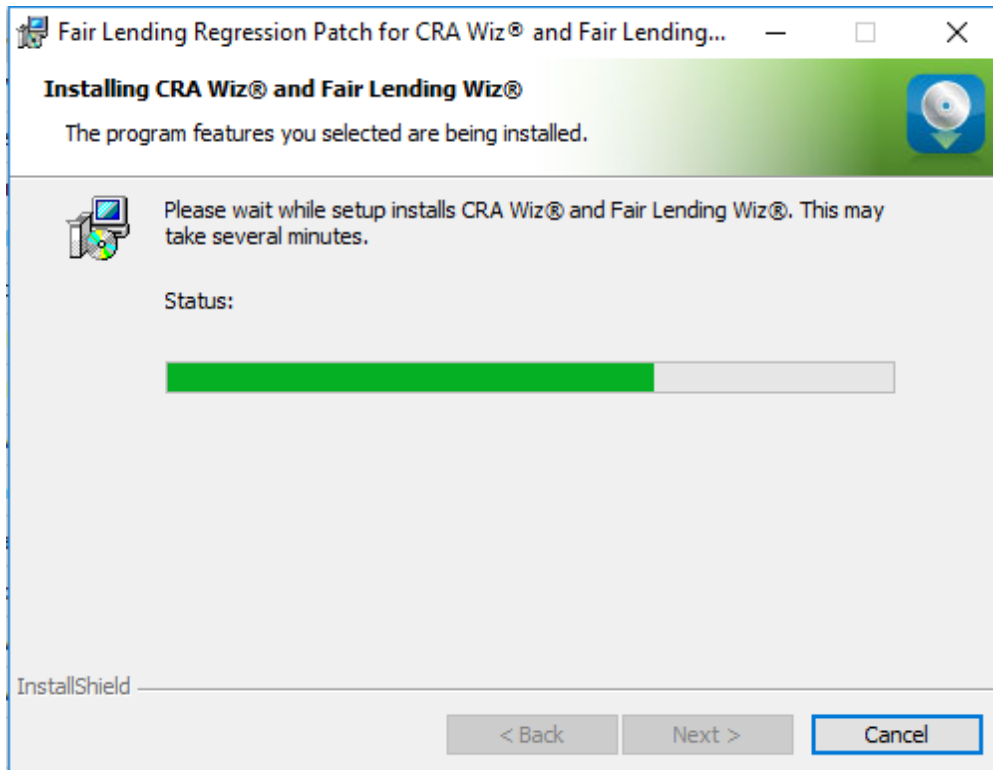
6. Click the **Next** button.

7. Click the **Install** button.

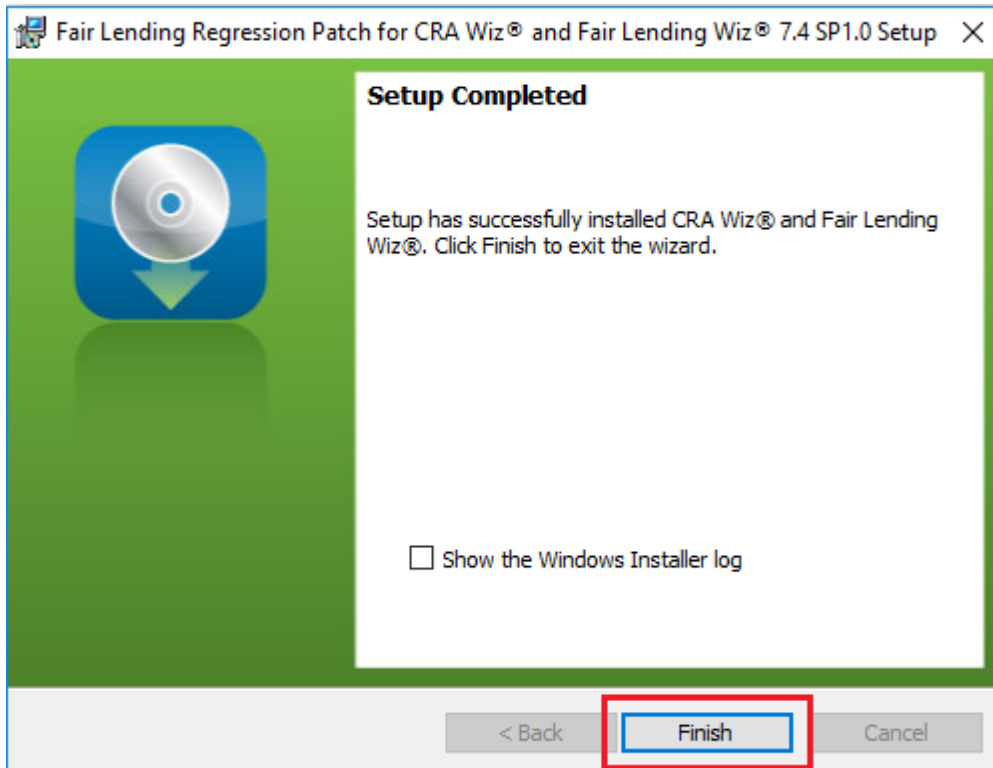
The installer runs the update:
