## 1 Overview

This release contains both a client and server update: Front-End Build: **75.10.40** Back-End Build: **75.10.129** 

The **CRA** *Wiz* and Fair Lending *Wiz* **7.5** Service Pack 1 (SP1) release contains updates to Fair Lending reports, the addition of 3 fields to the geocoding calculated fields, limited 2020 Census related data, and multiple application updates to support the 2020 Census Tract Boundaries.

### Important!

## 1.1 Who Should Install

All CRA Wiz and Fair Lending Wiz clients should install this update.

## 1.2 Where to Install

This update should be applied to both the application and the SQL server. In a typical networked environment, the installation should be run on both the client machine(s) and a server.

## 1.3 Prerequisites

The **CRA** *Wiz* and Fair Lending *Wiz* 7.5 Service Pack 1 (SP1) release can only be installed as an upgrade to the CRA Wiz 2021 Submission release (Front End Build 75.5.2 Back End Build 75.5.7). You must have the Submission release installed prior to applying this upgrade.

### 1.4 Required Permissions

This installation requires writing and modification, SQL server access, and registry modifications. Wolters Kluwer recommends that the user running the install have both Windows admin and SQL Server admin login credentials.

1.5 Required Free Disk Space

Client – 3 GB (gigabytes) Workstation – 19 GB (gigabytes)

1.6 Approximate Install Time Client – 14 minutes

Workstation – 25 minutes

## 2 Installation

To install the CRA Wiz and Fair Lending Wiz update, follow these steps:

1. Back up your SQL databases.

Wolters Kluwer recommends that institutions back up their SQL databases prior to installing a CRA *Wiz* & Fair Lending *Wiz* program update. Databases that should be backed up include:

- ObjectStore
- General
- USCensus
- CRB
- Procedure
- All Wiz\_# databases

### Important!

It is strongly recommended that you exit all Windows<sup>™</sup> programs before running this installation. This installation updates selected program files but does not overwrite any user imported files or custom settings created in prior versions.

- 2. Download the update locally where CRA Wiz and Fair Lending Wiz is installed.
- 3. Right-click the **setup.exe** file.

The software displays a contextual menu.

#### 4. Select Run as Administrator.

### Note:

The software displays the SQL Server Login screen only if the computer on which you are installing the update is running **SQL Server**. If the installer does not detect SQL Server on your computer, the installer displays the **Ready to Install the Program** screen. **Skip to Step 12**.

- 8. In the SQL server that you are installing to: field, do one of the following:
  - Enter the name of the SQL Server to which you are installing the data:

- 9. Choose one of the following authentication options:
  - Use Windows Authentication
  - Use SQL Server Authentication If you select this option, you must also enter your SQL Server account User Name and Password in the User Name and Password fields.
- 10. Click the **Next** button.

If your SQL Server installation does not meet requirements for installing CRA *Wiz* and Fair Lending *Wiz*, the software displays the following message:

## 3 Confirming Installation

To confirm that the Submission Update has been installed properly, follow these steps:

- 1. Launch CRA Wiz and Fair Lending Wiz.
- 2. In the menu bar, select Help > About CRA Wiz:

## 4 Geocoder Remove Access Database Dependency

An architectural change was made to CRA *Wiz* and Fair Lending *Wiz* with this release to remove the dependency on the **geo.mdb Access** database for Geocoding functions. The tables from the **geo.mdb** file have been incorporated into the **USCensus** database in SQL. Beginning with this release, the Geocoder will now retrieve the necessary information from the **SQL database** rather than **geo.mdb** Access database.

With this change, the **Microsoft Access Database Engine** component is no longer required for the Geocoder to function properly. This will eliminate "The Microsoft.ACE.OLEDB.12.0 provider is not registered on the local machine" errors in the **PCiAmSvr.log** and **PCiAmSvr.err** files. This error was logged with every record where the geocoder attempted to use ZIP Centroid match strategy, which resulted in the log files growing very large when attempting to geocode large LAR files. In addition, this will eliminate the situation in which the geocoder did not return a mmwStat code when it was unable to connect to the geo.mdb database.

### Note:

Other CRA *Wiz* and Fair Lending *Wiz* functions still rely on Access databases for data storage and retrieval. The Microsoft Access Database Engine component is still required for CRA *Wiz* and Fair Lending *Wiz* to use these remaining databases. Removing these remaining dependencies will be completed in future releases of CRA *Wiz* and Fair Lending *Wiz*.

To accomplish this change, a new **[SQLServer]** section has been added to the **PCiAmSvr.ini** file. The CRA *Wiz* and Fair Lending *Wiz* **SQL Server instance name** must be added to the **ServerName** parameter in this configuration file. The PCiAmSvr.ini file resides in the root CRA *Wiz* and Fair Lending *Wiz* directory on the client(s) machine and SQL server machine.

#### Important!

For those using the Windows Geocode Service, the update must be made in the **PCiAmSvr.ini** file in the **Queue Processor directory** of the Windows Geocode Service installation:
