1 Overview

Front End Build: **76.4.23** Back End Build: **76.4.17**

Important!

Please read the following **Release Notes** before installing this update. The notes contain important information about the enhancements included in this update:

The **CRA** *Wiz* and Fair Lending *Wiz* 7.6 Event Scheduler and Filter Hotfix release contains the following updates:

- Fixed issue in which **Event Scheduler** was using the wrong **Census Year** during **Batch Geocoding**, which resulted in **Validity Errors**. Note that the Hotfix will not automatically update your file. To update your file, do the following:
 - Right-click the existing **event**, select **edit**, then select your **geocoding task**.
 - Re-select the file referenced in the path (you will need to repeat this process for each geocoding task), then **save** the event.

Once that is done, the events should see your files as a part of the 2020 Census and will geocode accordingly.

- When creating a **New Event** or **Updating** an existing one, users should ensure the **associated tasks match the selected Census Boundary year**. Added pop-up messaging as a reminder.
- Fixed issue that when filtering for % Black and Hispanic values on the Columnar Reports, Map, or with Create Areas, the software was returning incorrect values. If you have previously used filtering for % Black and Hispanic values on Columnar Reports, Map or Create Areas, please regenerate. Moving forward, the filter will return correct results with any newly created Columnar Reports, Maps, or Create Areas.
- Fixed issue with **Map** that when trying to apply an assessment area, for some users the software did not display the **Apply** button. Users will now be able to see the Apply button if it was not displayed previously.
- Fixed issue in which the CRA *Wiz* and Fair Lending *Wiz* installer would place SQL Server into Single User Mode. No user action needed.

All CRA Wiz and Fair Lending Wiz clients are required to complete this update.

1.1 Where to Install

This update should be applied to both the application and the SQL server. In a typical networked environment, the installation should be run on both the client machine(s) and a server.

1.2 Prerequisites

To apply an update to CRA *Wiz* and Fair Lending *Wiz*, you must already have one of the following versions installed:

- 1. CRA Wiz and Fair Lending Wiz 7.6 (76.0.XX)
- 2. 2022 Submission Update (76.2.XX)

1.3 Required Permissions

This installation requires writing and modification, SQL server access, and registry modifications. Wolters Kluwer recommends that the user running the install have both Windows admin and SQL Server admin login credentials.

1.4 Required Free Disk Space

Client – 500 MB (megabytes) Workstation – 18 GB (gigabytes) Server – 18 GB

1.5 Approximate Install Time

Client – 10 minutes Workstation – 50 minutes Server – 50 minutes

1.6 Confirming Installation

To confirm installation of the Hotfix, check that the front-end and back-end build numbers begin with **76.4.XX.**

2 Installation

To install the CRA Wiz and Fair Lending Wiz 7.6 Event Scheduler and Filter Hotfix, follow these steps:

1. Back up your SQL databases.

Wolters Kluwer recommends that institutions back up their SQL databases prior to installing a CRA *Wiz* & Fair Lending *Wiz* program update. Databases that should be backed up include:

- ObjectStore
- General
- USCensus
- CRB
- Procedure
- All Wiz_# databases

Important!

It is strongly recommended that you exit all Windows[™] programs before running this installation. This installation updates selected program files but does not overwrite any user imported files or custom settings created in prior versions.

- 2. Download the update locally where CRA *Wiz* and Fair Lending *Wiz* is installed.
- 3. Right-click the CRAWiz76EventSchedulerFilterHotfix.exe file.

The software displays a contextual menu.

4. Select Run as Administrator.

The installer displays the **Welcome** screen:



Note:

The Welcome screen text indicates that you are about to update the current version of CRA *Wiz* and Fair Lending *Wiz*. If the installer does not detect your current installation of CRA *Wiz* and Fair Lending *Wiz*, please contact **Wolters Kluwer Technical Support at 1-800-261-3111**. When prompted, select **option 1**.

5. Click the Next button. The software displays the SQL Server Name screen:

Note:

The software displays the SQL Server Login screen only if the computer on which you are installing the update is running **SQL Server**. If the installer does not detect SQL Server on your computer, the installer displays the **Ready to Install the Program** screen. **Skip to Step 12**.

- 6. In the SQL server that you are installing to: field, do one of the following:
 - Enter the name of the SQL Server to which you are installing the data:

• Click the drop-down arrow located at the end of the field to select the Database server from a menu list:

- 7. Choose one of the following authentication options:
 - Use Windows Authentication
 - Use SQL Server Authentication If you select this option, you must also enter your SQL Server account User Name and Password in the User Name and Password fields.

8. Click the Next button.

If your SQL Server installation does not meet requirements for installing CRA *Wiz* and Fair Lending *Wiz*, the software displays the following message:
