## 1 Overview

### 1.1 Introduction

#### Important!

Wolters Kluwer strongly recommends reading through the following release notes and installation instructions before proceeding.

The IRS Report Update includes changes to the IRS report which is an optional report generated during CRA submission. The value for Total Number of Assessment Areas is incorrect and is not displaying all the Assessment Areas selected in the Submission Wizard.

This script update **only impacts the CRA IRS Report** and does not impact the HMDA or CRA Submission File.

Wolters Kluwer recommends the following:

- If you have not yet created your CRA submission file using CRA *Wiz* and Fair Lending *Wiz*: Install this IRS Report Script **before** you create your CRA submission file if you plan to also use the IRS report.
- If you already have submitted your CRA submission file: Run the IRS Report Script, then proceed through the Submission Wizard again using the same submission file and print a new IRS report.

Important! This update does not change the front-end or back-end build numbers.

#### 1.2 Database Backups – IMPORTANT!

Wolters Kluwer recommends performing a backup of the following CRA *Wiz* and Fair Lending *Wiz* database before running the update scripts:

#### 1.3 Who Should Install

Any client using CRA Wiz and Fair Lending Wiz for CRA data submission.

#### 1.4 Prerequisites

- CRA *Wiz* and Fair Lending *Wiz* 7.7 (back-end build 77.0.164) is required to apply this update.
- **SQL Server Management Studio (SSMS)** is required to execute this script. If you do not have SSMS installed, you can download SSMS from the following link and then install:

### 1.5 Where to Install

These scripts need to be executed within **SQL Server Management Studio** while connected to the database server where CRA *Wiz* and Fair Lending *Wiz* is installed. **There is no client-side update needed**.

### **1.6 Required Permissions**

Wolters Kluwer recommends that the user running the script have both Windows admin and SQL Server admin login credentials.

# 2 Release Notes

This Script update **only impacts the optional CRA IRS Report** and does not impact the HMDA or CRA Submission File.

The IRS report is only offered for users as an option to print during CRA Submission using the CRA *Wiz* and Fair Lending *Wiz* **Submission Wizard**. The report is not included as part of the CRA Submission file.

**Issue resolved**: The IRS report is displaying incorrect value for **Total Number of Assessment Areas**. Specifically, the report is displaying the number of assessment areas that was previously selected in the submission wizard:

- If you have not yet created your submission file using CRA *Wiz* and Fair Lending *Wiz*: Wolters Kluwer recommend you run the IRS Report Update script before you create your submission file if you plan on also utilizing the IRS report.
- If you have already submitted your CRA submission file: Proceed with updating CRA *Wiz* and Fair Lending *Wiz* with this IRS Report Script. Then recreate your submission file and reselect the IRS report to generate an updated IRS report with the correct Assessment Areas values.

To validate the correct number of Total Number of Assessment Areas, follow these steps:

- 1) Open the unencrypted submission file (cra.dat) in Windows Notepad.
- 2) Scroll down to the last row.
- 3) Find the plus (+) sign in the line value.
- 4) The **Number of Assessment Areas** should be indicated by the four (4) digits in front of the plus sign:
